Combatting COVID-19

As we approach the one-year anniversary of the COVID-19 pandemic, **Delaware Health Information Network (DHIN)** continues to support our State's public health response.

COVID-19 Results at Your Fingertips

When the Delaware Division of Public Health (DPH) needed a quick, reliable and secure way to make COVID-19 test results available to patients who were tested at participating Walgreens, DHIN responded with our personal health record, Health Check Connect*. With [Health Check Connect](#), provided free of charge to patients, users can access their test and lab results, read submitted doctors' notes and add information about prescriptions.

Through this partnership between DHIN, DPH and participating Walgreens, nearly 18,000 Delawareans have signed up for Health Check Connect since the summer.

As Delaware - and the nation - looks to leave COVID-19 in the rearview mirror, DHIN continues to explore opportunities to enhance this valuable service, bringing Delawareans closer to their health information.

Leading COVID-19 Lab Joins DHIN



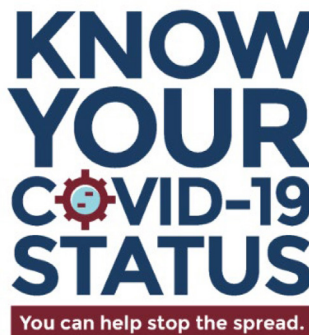
Curative is the latest lab to sign on as a DHIN data sender. A leader in on-demand public health service programs and infrastructure, Curative to date has processed nearly 800,000 COVID-19 tests for Delawareans.

Through DHIN's Community Health Record, healthcare practitioners have secure and on-demand access to the clinical information they need to care for their patients. Nearly 11,000 practitioners rely on the Community Health Record, which securely stores over 150 million clinical messages and results.

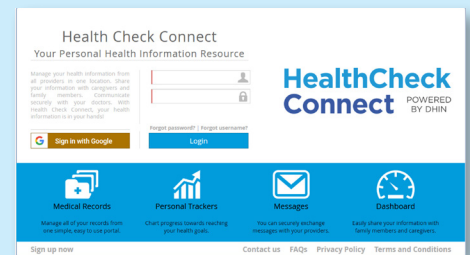

Conditions of Participation: What this Means for Healthcare Providers

Beginning in May, the Centers for Medicare & Medicaid Services (CMS) will require all hospitals, as part of its “Conditions of Participation” (CoP) for Electronic Notifications, to ensure a “reasonable effort” was made to send electronic notifications to PCPs, specialists, skilled nursing facilities and other clinical care partners at either the provider’s or patient’s request.

For practices, this CoP requirement may result in an increased number of electronic notifications about your patients. We’ll be providing additional details in the coming weeks as to how your practice may want to handle increased notifications, as well as to help answer any questions you may have.

Delaware Health Care Claims Database ~ Status Report

As part of its statutory responsibility, DHIN has submitted its 2020 **Delaware Health Care Claims Database (HCCD)** status report to Governor Carney and the General Assembly. Now at the end of its second year, the HCCD contains claims records for 720,000 unique persons, which represents more than 60% of Delaware residents.

A critical component in the State of Delaware’s goal to address inequities in healthcare spending and outcomes, the HCCD collects healthcare claims, enrollment and provider data from Medicare, Medicaid and commercial health insurers in the State of Delaware, making it the state’s single largest repository of claims data.

The HCCD is a crucial tool in helping policymakers, providers, researchers, insurers and others make healthcare decisions that impact Delawareans.

Current projects utilizing the HCCD include a cost of care report for the Delaware Health Care Commission, a community-based neurocognitive screening program for Christiana Care and an environmental impact study for the CDC, among others.

DHIN has also developed and published public reports of interest to clinicians, researchers, insurers and consumers.
